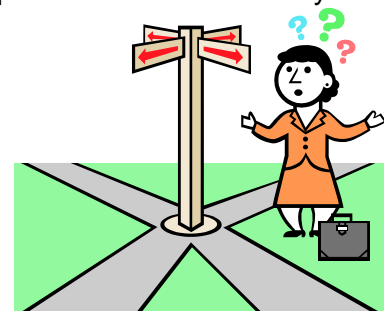

## Students' Corner

**New Eyes** by Jessica DeBoom

When I run across something multiple times in different areas of my life, like a name or a concept, I make it a point to take notice. This time it was a quote by Marcel Proust: "The real voyage of discovery lies not in seeking new landscapes but in having new eyes."

Let me explain.

Now that my summer classes are finished and I have some honest-to-goodness free time, I pulled up my mental list of things I've been meaning to do. This morning, I settled on putting together a scrapbook of a trip I took many years ago, a project I've started and stopped numerous times. As I sorted through pictures and memorabilia, I came across a compilation of travel quotes I had collected over the years. I paused to read through it. Although it contained many excellent quotes, Proust's really stood out to me.

Then this afternoon, I turned my attention to writing this article. I brainstormed for a while, trying to come up with an interesting topic about which to write. As I sat at my computer, my eyes began to wander around the room, in the general direction of one of my bookshelves. They landed on my copy of *Thriving: A Manual for Students in the Helping Professions*, one of the required texts for my Intro to Professional Counseling class. I grabbed it and started flipping through it for the first time since the end of the Fall 2008 semester. And there it was again – Proust's quote.

As I sat there, contemplating, I was reminded of something that was said the day I attended the group interview for admission into UNI's counseling program. Although I don't recall the exact words, we were told that the person who leaves the program will not be the same person who entered. At the time, I remember thinking that was a curious thing to tell us. It was such a global, certain prediction, yet stated in such a casual way. The idea was simultaneously exciting and terrifying. Was it a promise or a warning? As it turns out, it was both.

The students reading this who have just finished or are nearing the end of their program are probably nodding, knowingly.

For those of you just beginning your program, rest assured you will get lots of "new landscapes." You'll learn about counseling skills, interventions, diagnostic criteria, case conceptualization, and developmental and multicultural considerations, to name a few. And while all of those things are important, learning them doesn't actually change you. The change is much more abstract and occurs gradually, almost without notice. It requires students to take an honest look at themselves and the world around them, take chances and try new things, make new connections, and let the change happen. As a counseling student, that is how you get "new eyes."

## On the Legislative Front

*Erik Oostenink and Jim Wilwerding represented IMHCA at a joint meeting with the Iowa Association for Marriage and Family Therapy (IAMFT). Erik has provided the following details for IMHCA members' information. The IMHCA board will meet again on September 18, 2010 to discuss the outcome of this meeting and the future of the joint lobbying effort between IMHCA and IAMFT. Some of the goals are to increase access to providers, specifically with a couple of insurance companies (Principal/Coventry and Iowa Health Systems). This may be worked on legislatively as well as through both organizations meeting together with the state Insurance Commissioner. Principal often requires LMHC's and LMFT's to get supervision from an LISW, Ph.D. Psychologist, or MD. We have issues with the LISW part of the process.

Another legislative goal is to work on a Fair Practice Law. This would basically say that insurance companies would be required to accept groups of mental health practitioners by profession (SW's, MFT's, and MHC's). This would prevent insurance companies from discriminating against LMHC's and LMFT's and increase provider availability. We would still allow insurance companies to decide on credentials such as independent licensure and number of years of experience as we still want to ensure competent practitioners. Apparently, Oklahoma just put a law into effect saying something similar so we will try to model off of this. This will likely be met with resistance from the insurance lobby. We also would likely include Psychologists and Substance Abuse Counselors in this to ensure a strong coalition (SA would not be providing for MH, but for SA of course).

We also agreed to work on adding LMHC's to Medicaid. Emily did not think this should be very controversial and either will look to add it on to another bill or do a standalone. She will work with Amanda Ragan, Becky Schmitz, and Mark Smith on this. Although this would not affect us with Magellan, as we are covered by Magellan the same as SW's, it would improve opportunities for MHC's under IME with In-home Family Therapy under the CMH Waiver.

We also discussed the distaste for the term "temporary" in the licensure rules. We discussed how any changes to the terminology would need to come from the licensure board (my area now). We would want input from our membership as to what the terminology should be for the different tiers.

Also, related to access to providers, we would like to have stories from our membership of problems with clients or potential clients not being able to be seen due to provider panels being closed in their geographic areas or not being covered by providers in their areas. These stories can make a difference to legislators, particularly if they are military vets.

Cost wise, since we are looking at drafting new legislation, both the Fair Practice and the Medicaid area, the cost would be \$10,000 total or \$5000 for each organization. This would be payable at the end of the legislative session. We are planning another meeting after the state elections on November 22, 2010.
